Shiva's research started with the classics of the 20th century: Chauncey H. Griffith's 1938 Bell Gothic was his first stop, before proceeding to Matthew Carter's Bell Centennial, the uncredited Spartan Classified, alphabets designed for the IBM Selectric by Bud Kettler, and more recent takes on the genre like Erik Spiekermann's FF Meta (originally designed for the German postal system), David Berlow's Poynter Agate, Tobias Frere-Jones's Retina, Christian Schwartz's Amplitude, and our own Guardian Agate Sans. What Shiva took away from this was not so much a series of shapes to synthesize into a new sans serif as a set of methods for emphasizing clarity and legibility.

It was indeed only through the desire of an eighteenthcentury philosopher, Baumgarten, to round out his "architectonic" of metaphysics that the science received its name, as designating the theory of knowledge in the form of feeling, parallel to that of "clear," logical thought. Kant, Schelling, and Hegel, again, made use of the concept of the Beautiful as a kind of keystone or cornice for their respective philosophical edifices. Aesthetics, then, came into being as the philosophy of the Beautiful, and it may be asked why this philosophical aesthetics does not suffice; why beauty should need for its understanding also an aesthetics "von unten."

The State of Criticism

The answer is not that no system of philosophy is universally accepted, but that the general aesthetic theories have not, as yet at least, succeeded in answering the plain questions of "the plain man" in regard to concrete beauty. Kant, indeed, frankly denied that the explanation of concrete beauty, or "Doctrine of Taste," as he called it, was possible, while the various definers of beauty as "the union of the Real and the Ideal" "the expression of the Ideal to Sense," have done no more than he. No one of these aesthetic systems, in spite of volumes of so-called application of their principles to works of art, has been able to furnish a criterion of beauty. The criticism of the generations is summed up in the mild remark of Fechner, in his "Vorschule der Aesthetik," to the effect that
